In the last post we provided details about the rise and fall of the Roman Empire itself. We also identified the Roman Empire system that exists today throughout the world. Yes it has been upgraded with technology and legal rules and regulations mutating through time, but the underpinning foundation of the entire world system today is in some cases the absolute same and in others just a different version of the same.



FBI Director Herbert Hoover once stated that the individual comes face to face with a conspiracy so monstrous that he or she cannot believe it exists. The individual man or woman or child comes face to face with a global historical conspiracy so monstrous that he or she cannot believe it exists.

So, let's dig deeper into the systems of the Roman Empire and just see why and how they fit then and now. You should begin to see not only the current State of Israel and its role in this system but how your countries government today follow is today In order to understand why the State of Israel we must continue to review history just a bit the Roman Empire system.

In an article published in The Economist titled Monetarists Anonymous on September 29, 2012, it was stated that "GIVE me control of a nation's money supply, and I care not who makes its laws." So said Mayer Amschel Rothschild, founder of the Rothschild banking dynasty."

Sir Josiah Stamp, President, Bank of England (2nd richest man in England) stated "Banking was conceived in iniquity and born in sin. Bankers own the Earth. Take it away from them but leave them the power to create money, and, with the flick of a pen, they will create enough money to buy it back again. Take this great power away from them and all great fortunes like mine will disappear and they ought to disappear, for then this would be a better and happier world to live in. But, if you want to continue to be the slave of the bankers and pay the cost of your own slavery, then let the bankers continue to create money and control credit."

Abraham Lincoln, from a November 21, 1864, letter to Colonel William F. Elkins wrote "I see in the near future a crisis approaching that unnerves me and causes me to tremble for the safety of my country. As a result of the war, corporations have been enthroned and an era of corruption in high places will follow, and the money power of the country will endeavor to prolong its reign by working upon the prejudices of the people until all wealth is aggregated in a few hands, and the Republic is destroyed. I feel at this moment more anxiety for the safety of my country than ever before, even in the midst of war. God grant that my suspicions may prove groundless."

At the heart of any control of the system is the financial system.

Who Are The Bacharach Family

In the book titled Antiquity of the Jews written by an early Jewish Historian by the name of Flavius Josephus he writes of the Roman Empire control. He identifies that the Roman senate was started, funded and controlled by one family that went by the name of Bacharach. They managed and controlled the financial systems of Rome. This bloodline can be traced all the way back to Ham's bloodline, one of Noah's sons. It was through Ham's bloodline that reconnected to the fallen angels continuing the bloodline of Cain.

If you recall the senate and the house of Rome was called the Sanhedrin. It was Augustus who was ruler of Rome at the time Yeshua the Christ.

The Great Sanhedrin dealt with religious and ritualistic Temple matters, criminal matters appertaining to the secular court, proceedings in connection with the discovery of a corpse, trials of adulterous wives, tithes, preparation of Torah Scrolls for the king and the Temple, drawing up the calendar and the solving of difficulties relating to ritual law.

In about 30 C.E., the Great Sanhedrin lost its authority to inflict capital punishment. After the Temple was destroyed, so was the Great Sanhedrin. A Sanhedrin in Yavneh took over many of its functions, under the authority of Rabban Gamliel. The rabbis in the Sanhedrin served as judges and attracted students who came to learn their oral traditions and scriptural interpretations. From Yavneh, the Sanhedrin moved to different cities in Galilee, eventually ending up in Tiberias.

Local Sanhedrin consisted of different numbers of sages, depending on the nature of the offenses it dealt with. For example, only a Sanhedrin of 71 could judge a whole tribe, a false prophet or the high priest. There were Sanhedrin of 23 for capital cases and of three scholars to deal with civil or lesser criminal cases.

John 8:44 Christ was speaking to the Sanhedrin “Ye are of your father the devil, and the lusts of your father ye will do. He was a murderer from the beginning, and abode not in the truth, because there is no truth in him. When he speaketh a lie, he speaketh of his own: for he is a liar, and the father of it.”

The Bacharach bloodline continues today. We know them by a different name – The Rothschilds. The Bacharach bloodline changed their name to Bauer in 1501 and in 1577 they changed their name to Rothschild.

While the name of the financial system throughout time has changed its name the underlying system was that one family would control the world of finance just like in the days of the Roman Empire. Whether it be The Knights Templar or the Central Bank today it has been one system. The name changes to Rothschild in 1577 gave them the cover to become the controlling family of the Roman Catholic Church financial system called the Vatican Bank.

Through this control a group of elites would join the Rothschild in creating the world’s largest cartel system with the head of the system lucifer himself. We will not address the structure of this system because it is in its own a larger rabbit hole outside of this particular subject.

Because of the Rothschild family gaining complete control over the world financial system via means of leverage to control governments, whole societies, and our daily lives of living slaved to a system that they tell us we have control but in reality we have very little if any control over it. The structure set up for every government in the world is a series of corporations that are not connected to the people and therefore the legal system of world governments is completely separate from the laws their government uses to control the people. Yes, a world two-tiered legal system that along with the financial system isolates the people into total slavery.

The Roman Catholic Church

If you study your bible at all and understand the Old Testament and New Testament you then understand that the Old Testament was ruled by Kings and the New Testament was and is today ruled by Empires. There were no religions in the Old Testament. It is quite clear that there was a two-tiered worshipping system that was either focused on God or lucifer. There was a clear distinct of who worshiped whom.

It was because of Yeshua the Christ coming to establish the final blood sacrifice and give us redemption of salvation that required a systemic change beginning with the Roman Empire. As stated in our Post Four, the Roman Empire was trying to determine whether this Christ had come to rally the people to over through the Empire. When the Empire understood that their Empire and their systems were being verbally attacked instead of a war they set forth a religious system to offset the teachings of Christ in the form of the Roman Catholic Church. This literally was the first church.

To examine this conspiracy let's look at the time ology of the greatest Global cover-up and modern history creating Christianity.

The timeology of the greatest conspiracy in Pre- and Post-modern history begins at the year of 753 BCE before the Common Era of the birth of the Christ.

The ancient Roman entity was designed by twins Romulus in Remus whose bloodline goes back to Nimrod to the Babylonian Empire of Genesis Chapter 10. The Roman Empire gave birth to the Vatican system so Rome in 753 BCE. Then the Vatican system was birthed through their first pope which we have been taught a lie that it was Saint Peter. It was not.

Saint Peter one of The Twelve Apostles of the Christ was martyred by Nero the emperor of Rome in 67 A.D. So how can the Vatican put out a lie for the past 400 years stating that Saint Peter was the first Papa or Pope but yet the same system crucified him upside down.

So, the apostolic fathers didn't come out of the Vatican system. The apostolic fathers came up out of Acts two.

The Vatican system was also birthed going back to Acts 8 with Simon Magus the magician whose name was actually called Simon Makus Pater which is a Latin Vulgate expression meaning Peter. Here's the deception. The first Papa or Pope was a warlock.

God had taken out Simon Makus through judgment according to the writings of Josephus in volume 1 of the Antiquity of the Jews. Josephus said that Simon makos who also gave birth to the bloodline of the popes died of a venereal disease in his private parts. That is the creator of the Vatican system whose bones is in the Basilica to this day not Simon Peter's bones.

The Roman Empire centuries later had Incorporated the Vatican system on the 11th of February in 1929 through the Lateran Treaty signed between Pope Pius the 11th and Benito Mussolini. Upon ratification of the Lateran Treaty, the papacy recognized the state of Italy, with Rome as its capital. Italy in return recognized papal sovereignty over the Vatican City, a minute territory of 44 hectares (109 acres) and secured full independence for the pope. A number of additional measures were agreed upon.

Mussolini declared that the Vatican City is the capital of the religious world. Now the term Vatican as comes from a Latin Vulgate expression Vatican-ness. The term Vatican anus was named after the Roman god Vegeta or vaginal. Vegetanus,

according to the Codex, which is the Otis a manuscript written in Greek that's located in the Basilica within the Vatican system, that the Vatican Seven Hills was named after the Roman god veget anus - the god of sexuality.

So, the term Vatican anus also comes from two Coptic meanings. The Valtier which means soothsayer and the term Canol which means to sing and to chant.

The Vatican Basilica was built actually by the Roman Empire through Caesar Augustus but the bones in the Basilica are those of a warlock and a witch out of Acts 8 who wanted to purchase the anointing who wanted to market the anointing and to purchase the title of apostleship.

So, then this is where you get the term purgatory a painful The Souls of the Dead. That doesn't come from Saint Peter the Apostle that came from Simon Makus Pater in Acts 8 verses 9 to 24.

The term primary or primate is a vaticanized term according to the writings of the apostolic father Justin Martyr. He said that Saint Peter was not the first pope because Saint Peter in 45 A.D was in Jerusalem in a jail cell in prison in Acts 12. Then four years later in 49 A.D Saint Peter was in Jerusalem at the Jerusalem Council and two years later in 51 A.D Saint Peter was an Antioch of Syria not in Rome. So, Peter was not the bishop of Rome. Saint Paul was because Rome was not a part of the Jewish diaspora. Rome was a part of the Gentile. Remember Christ made Peter over the delivery of His Christology to the Jews and Paul over the Gentiles.

It was at Antioch, through the emperor Claudius who was also governor of Antioch, that had designed a tax bracket code called Christian which would become the future 501c3. That tax bracket code was called Christian.

Nowhere in the scriptures did Christ command us to call ourselves Christians. This is radical because the term Christian is a tax bracket code designed by the emperor Tiberius Claudius Caesar Augustus or August Germanicus from whence we get the future bloodline of Prussian and German Empires. So, the emperor Claudius designed a tax bracket code in order to weaken the Apostolic Church of Acts 2. When you identify as a Christian or an entity called Christianity you just cursed yourself by saying that I am a tax bracket code. You are not. Christ did not command the apostles the 12 to 70 the 120 in the upper room to 3 000 on Pentecost to call yourself Christian. You are the followers of the Christ. You are Disciples of the Christ.

It was at this time that the emperor Tiberius Claudius Caesar Augustus laid the groundwork that would be later picked up by Constantine to create a religious colonization system called Christianity- anity. The term anity is a Roman term under Roman law meaning to colonize to infiltrate the Acts 2 Church.

Christ does not want you to call yourself Christian because you're not a tax bracket code neither does Christ want you to follow Christianity. He doesn't want you to colonize the Apostolic Church by vaticanizing it with Rome.

According to the law library collection of Oxford University of Roman law and according to the institutions of the law of Gaius and the law of Justinian we are told that the Roman Empire continued in the east by the creation of the Byzantine Empire.

In Roman law the term Christian also means innovation. So, the term Christian is not only a tax bracket code but according to the Eastern Roman Empire, ruler Justinian, also created with tax dollars tax in the episode Church of Acts 2, created the city of Constantinople on tax dollars of taxing the Church of Acts 2. Justinian had said that the term Christian means innovation. His innovation was making money off of the backs of the Apostolic Church in Acts 2.

The Constitutional law of the Roman Empire later through the Justinian Commission where 12 jurists, a global body of Roman attorneys, had created Roman language dialect and speech political and entertainment structures that will last throughout historical posterity. The Romans divided their laws into two distinct paradigms the written law called scriptum and two unwritten law called jus non-scriptum which means the vaticanization of the earth through customs and traditions.

The Roman senate will give birth to a two-party system here in the United States of Democrats and Republicans. The Democratic party the Republican Party are two heads of the same snake that was birthed first in the garden and matured through Roman law creating Christianity.

My people are destroyed for the lack of knowledge. So, Roman law created the Roman law of the 12 tables. Anything that Christ created 12 Apostles satan brings a counterfeit. The law of the Twelve Tables is called in Latin Lex 12 Tabularum. From 451 to 450 BC the 12 Roman tables a counterfeit of the apostolic 12 where throughout posterity language dialect speech accent would be all rooted in a Romanized script of language.

All 9 000 plus languages upon the Earth have their roots in Rome. All 14,000 dialects have their roots in Rome. All 33,500 accents have their roots in Rome. So, the Roman Empire knew that they would not last but the spirit of the letter of Roman law would continue to this very present day. The 12 tables of Roman law were written by 12 commissioners of the Roman Empire a secret society called the Decemvirs.

December is the 12th month on the Gregorian calendar given by the fallen angels to the daughters of men and Genesis 6 Enoch 6 June 6 - 666 and also given to Saint Gregory in the 1500s.

The Decemvirs were one percent of the Roman Empire, but the general public called them the plebeians. The plebeians are the vassal state. So, what we call Vassal States now we got 50 states in the United States these states are actual vassal States where each governor represents a governor or a spirit guide.

The governor represents what we call a spirit guide. Well, what is a spirit guide – glad you asked.

A spirit guide work creates and projects the psychological mindset of its constituents who are nothing but house pets because the term constituents or constituency goes back to Roman law during the time of Caesars. The law of the Romans calls the Twelve Tables or the lex tables where the term constituent means the house pet of the system. So, it doesn't matter whether you are a Republican or Democrat or independent a governor is called a Tetrarch.

So, the governor is a spirit guide over the four corners of a state. What state? The state of the minds of the house pets called the constituents where the Spirit guides or the governors, they govern the minds of their house pets.

Through the Roman law of today it establishes the color of law. All of this is Christianity. It establishes the color of law or the law of color according to the blacks dictionary it says in the fifth edition that the term color is the semblance of the exterior house of that which is not authentic. The color of law or the law of color according to the Black's Law Dictionary fifth edition that color is a deceptive appearance that is not authentic but becomes policy. The color of law or the law of color is the exterior concealing the lack of ality which now it becomes reality. The term colored or that which is enslaved. A collar Menace is wearing a vaticanized collar and to be collard walked around by a slave master called a governor doesn't matter what color you are to the system you are nothing you're nothing but a vassal state.

We the people are an illegal entity with no rights. This is according to the color of law of the law of color in the Black's Law Dictionary fifth edition that color is defined as the legal undoing of God's law of the supernatural. You're nothing but Chattel. It doesn't matter what your ethnicity is. See the devil is a liar.

The color of law or the law of color came from the Roman Empire Law of the 12 tables of Roman legalized law. Color is also a signature.

Look at the first three letters of the term signature from whence you get the term sigil. When you type in the term sigil on Google Images you will see a multiplicity of luciferic symbols. So, your signature of sigil nature. When you say I'm signing my life away that's what you're doing then you become a ward of the state through the self-cursing of a signature or the nature of a sigil that represents all going back to Roman Empire Law stay there in Acts 1.

After deposing the last western emperor, Romulus Augustus, Odovacar's troops proclaimed him king of Italy, bringing an ignoble end to the long, tumultuous history of ancient Rome. History tells us that the fall of the Roman Empire was complete. But was it? You should now know the answer to this question.

The Roman Empire was never conquered. The Roman Empire fell because of the weight of its own bureaucracy. But the Roman Empire system was spread to all of the Middle East and all of Europe. As you can see above the Byzantine Empire was an extension of Rome. Italy today is an extension of Rome. In fact, the city where the Roman Catholic Church is located is called the City of Rome. What went with the spreading of the Roman Empire – the money system, the governmental laws, the Roman Catholic Church and the people who were in control over all this – the Bacharach family.
